10. Copyrights The Makeup Artist shall maintain the copyrights of all makeup and shall seek the Clients permission to make copies of Client's images for professional use. Any sale, publication, or distribution of any information of artist's work is prohibited without the consent of the Makeup Artist.
11. Term This Contract shall start on the effective date and shall end on unless and otherwise terminated.
12. Termination This Contract shall be terminated if any of the following events occur:
Either Party breaches the Contract;
2. The Makeup Artist does not provide the necessary services to the Client;
3. The Client does not make the payment on time.

13. Limitation of Liability

The Makeup Artist confirms that all the brushes, tools, and makeup products are sanitized between every makeup application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported by the Client to the Makeup Artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client agrees to release the Makeup Artist from liability for any skin complications due to allergic reactions.

14. Indemnification

The Client agrees to indemnify the Makeup Artist against any claim, damages, cost, loss, expense, or any kind of liability arising by the Indemnities in connection with any claims, suits, demands, arising out of this Contract.
